Experimental "Pulse" Survey for Small Businesses and Households During the COVID-19 Pandemic

These two surveys are in no way connected to the 2020 Census. However, in response to the unprecedented circumstances due to COVID-19 and the urgent need for data, the U.S Census Bureau is launching two new experimental surveys to measure temporal social and economic trends in the nation's small businesses and households over the next three months.

Small Business Pulse Survey includes limited number of questions on topics such as location closings, changes in employments, disruption in the supply chain, the use of federal assistance programs and expectations concerning future operations. The survey should take up to five minutes to complete.

Household Pulse Survey is a 20-minute online survey studying how the COVID-19 pandemic is impacting households across the country from a social and economic perspective. The survey asks about how the jobs, finances, access to food, health, housing and schooling has been affected by this crisis. If you have been selected, you will receive an email from **COVID.survey@census.gov** with a link to complete the survey. You also maybe contacted via text message to your phone. You may also receive follow-up reminders if you haven't received your response.

Your responses are very important and protected by law. These statistics help inform leaders about our communities impacted by the pandemic.

If you have receive your Census invitation on the mail with your Census I.D, please go online, over the phone or submit your paper questionnaire. However, if you have not yet received your Census I.D, especially if you have a P.O Box, we ask that you kindly wait until mid-June when we hope to get back to the field and safely deliver your Census packet to your door.
